**ORDINANCE #17– 2017 AN ORDINANCE AMENDING CHAPTER 175-32, OF  
THE CODE OF THE CITY OF MARGATE CITY, COUNTY OF ATLANTIC  
AND STATE OF NEW JERSEY (*McLarnon*)**

This Ordinance changes building height to 30 feet with conditions.

The bulkhead project at Decatur Avenue is now complete and a maintenance bond has been issued.

#198-2017 Authorizing the Execution of a Deed of Dedication and Perpetual Storm Damage Reduction Easement Between the City of Margate City and the State of New Jersey and the Army Corps of Engineers. (*Deaney*)

The resolution allows the State of New Jersey and The Army Corps use of the beach for the construction of manifold and pipes for stormwater drainage system.

#199-2017 Authorizing the Execution of a Local Cooperation Agreement Between The Department of Environmental Protection and the City of Margate City for the Construction of a Storm Water Management System in Conjunction with the Brigantine Inlet to Great Egg Harbor Inlet, Absecon Island, New Jersey Hurricane and Storm Reduction Project Number 6057-I (*Deaney*)

The resolution is authorizing an agreement with NJDEP so as to allow construction of stormwater management system along beach front.
