

**RESOLUTION #207-2016**  
**AWARD OF CONTRACT for 2015-2016 ROAD PROGRAM**

**WHEREAS**, the City of Margate authorized the receipt of bids for 2015-2016 Road Program on September 1, 2016; and

**WHEREAS**, the City Clerk did duly advertise the receipt of said bids in the Press of Atlantic City on September 30, 2016

**WHEREAS**, in connection therewith the following three (3) bids were received by the City of Margate on October 12, 2016:

**WHEREAS**, the City Engineer, Edward Walberg of Remington Vernick & Walberg recommended that a contract be awarded Lexa Concrete, LLC, 11 Commerce Way Drive, Hammonton, NJ 08037, as per their proposal 2015-2016 Road Program at a cost not to exceed \$1,410,319.10; and

**WHEREAS**, the Chief Finance Officer has certified to the City Commissioners that there are adequate funds available for the purpose of award of this contract in the following account  
Capital Ordinance #2016-05 C-04-55-978-903 for \$679,319.10 and Capital Ordinance #2016-06 C06-55-908-903 for \$731,000.00 totaling \$1,410,319.10; and

**NOW, THEREFORE, BE IT RESOLVED**, by the City Commissioners of the City of Margate, County of Atlantic that it does hereby award a contract to Lexa Concrete, LLC, 11 Commerce Way Drive, Hammonton, NJ 08037, as per their proposal 2015-2016 Road Program at a cost not to exceed \$1,410,319.10; and
