

Public Comment: John Sewell urged shared services with Ventnor. Steve Altman asked for more open discussions by commissioners in the meetings. Sharon Simon commented on the amount of complaints about the school board & that changes are needed & asked for clean copy of Ms. Taube's letter to auditors regarding City Clerk or an explanation of redactions made. Steve Woerner stated city's portion of county taxes too high (*Mr. Hiltner: based on net valuation within municipalities not size*) & suggested looking closely before entering into any agreements with Ventnor. This portion was closed on motion by Ms. Taube with a vote of 2 ayes.

Public Comment on Agenda Items: John Sewell questioned Ordinance #13 & asked that all ordinances & resolutions be placed in full on the website prior to meetings. Sharon Simon commented on Ordinance #13 & stated that the school board should provide complete information to commissioners prior to any vote needed.
