The Regular Meeting of the Board of Commissioners began at 5:00 p.m. with a flag salute and roll call: Mr. Becker & Mr. Blumberg were present. Ms. Taube was absent. Mr. Deane and Mr. Abbott were also present. The minutes from April 4, 2013 were approved as read on motion with a vote of two ayes.

Public Comments: John Sewell spoke on the prospect of rising flood insurance rates, hiring & wage freeze, and banning nepotism. Art Cautilli requested a stop sign on Jerome & Marshall Avenues or at the end of Marshall Avenue. Sharon Simon asked about the rumor of illegal contributions made to Little League (commissioners hadn't heard but denied). Mr. Bessner spoke against flashing lights on Atlantic Avenue and asked reasoning for doing so (Chief Wolfson explained). Willie Jacovini spoke against fencing in any part of the UAS playground for a parking lot and suggested going through the summer and re-evaluating the need later (Mr. Blumberg agreed).
