January 16, 2014 Margate City, New Jersey

Bids were received on January 14, 2014 as advertised for **Beach Bulkhead Repairs & Sumner Avenue Bulkhead Replacement** & complete results may be found in the following pages.

The Board of Commissioners held its Regular Meeting on the above date at 5:00 p.m. The meeting began with a flag salute and roll call: Mr. Becker, Mr. Blumberg, & Ms. Taube were present. Mr. Deaney & Mr. Abbott were also present. The minutes from January 2, 2014 were approved as read on motion by Mr. Blumberg with a vote of three ayes.

**Public Participation:** John Sewell – make shared services for schools with Ventnor a reality. Ann Pancoast – any documentation on lifeguard shacks advertising (*Mr. Becker: city is working on a report*). Steve Woerner – questioned advertising on boats and lifeguard shacks (*Mr. Becker: individuals bought the boats*); advertising on lifeguard beach umbrellas should be disallowed; any explanation on "missing" money from beach shacks advertising (*Mr. Deaney: no money is missing rather payments were not made by advertisers as per the contract*). Willie Jacovini – more important things to be concerned about than the beach advertising especially since it all saves the City money. Dan Gottlieb – asked Mr. Abbott to explain comments made to reporters re the possibility of the governor extracting revenge if Margate defies the DUNES project (*Mr. Abbott denied these comments and stated Margate is still working towards a meeting with DEP Commissioner*). Sharon Simon suggested more optimism rather than defeatism when discussing City opposition to the project. On motion by Mr. Blumberg this portion was closed with a vote of three ayes.

**Public Participation on Agenda Items**: John Sewell questioned Resolutions #22 (*the grant is for* \$2,000 *it is not payment to the grant writer*) and #26 (*discussion with city attorney re status of Hiltner v. City of Margate & strategies for upcoming trial and further discussion concerning the attorney's fees*). On motion by Ms. Taube this portion was closed with a vote of three ayes.
