Rutala Associates, LLC, 717 River Drive, Linwood, NJ 08221, for assistance to the City of Margate City with the implementation of 2022 Planning and Grant Assistance;

WHEREAS, James M. Rutala Associates, LLC, 717 River Drive, Linwood, NJ 08221 submitted a proposal of \$24,000.00 for 2022; and

WHEREAS, this Contract is awarded without competitive bidding because it is a Professional Services Contract and is an exception to the Local Public Contracts Law, N.J.S.A. 40:11A-5 (1)(a)(i).; and
