**WHEREAS**, the City Purchasing Agent, Roger McLarnon, submitted his letter dated May 20, 2019, that a contract be awarded to Paul Van DeRijn, 2511 Fire Road, Egg Harbor Township, New Jersey 08234 as per their proposal to provide Beach Vending License for the 2019 Beach Season in an amount \$33,000.00; and

WHEREAS Paul Van DeRijn is the highest proposal for these services; and

**NOW, THEREFORE, BE IT RESOLVED,** by the City Commissioners of the City of Margate, County of Atlantic that it does hereby award a contract to Paul Van DeRijn, 2511 Fire Road, Egg Harbor Township, New Jersey 08234 in an amount not to exceed \$33,000.00 as per their proposal to provide Beach Vending License.
