The Margate City Board of Commissioners held a work meeting on the above date at 4:00 p.m. The meeting began with a flag salute & roll call: Mr. Becker and Mr. Amodeo were present. Dunes' hearing begins February 4<sup>th</sup> at 9am in front of Judge Mendez.
