Scott Abbott- License agreement for 9401 Ventnor Ave. more information is needed. Bulkhead Property Subdivision is moving forward and their response for replacing Bulkhead administration or planning board. Deed restriction of 25 ft. Lighting Engineer was sought and engaged, Dark Sky International to draft process. Lighting is hard to measure.

John Amodeo-Jitney Route- Along with Mayor and Commissioners agree to not have stops in Residential areas. We feel we could still do a 45 day test pilot run. 9am to 3pm may be added.
