Mr. Patterson inquires as to the deck size.

Mr. Mednick describes the rail around the skylights.

Mr. Cristaldi inquires as to the two decks on the second floor.

Mr. Richmond inquires as to the noise.

Mr. Collins inquires as to the size being twelve by twelve.

Ms. Guber-Nulty inquires as to the beach view with new construction next door.

Commissioner Taube inquires as to looking down on neighbors.

Mr. Cristaldi inquires as to the parapet being moved.

Mr. Richmond informs the Board of a forty two inch BOCA Code railing height.

Mr. Bergman reviews the C variance with conditions, and revised plans are required.

Motion to approve the C variances was put forth by Ms. Guber-Nulty and Mr. Collins seconded. The motion was approved, four in the affirmative and three in the negative. Ayes; Collins, Richmond, Taube and Guber-Nulty. Nays - Wasleski, Cristaldi, Patterson.

Mr. Wasleski informs that an Engineer is only on very type specific plans.

Mr. Rubin refers to a State Affidavit which Mr. Galantino has in his possession.

The Board votes by way of unanimous voice that an Affidavit of Compliances shall become part of the application package, which affidavit shall be sufficient by Solicitor Bergman .
