

RESOLUTION #151 of 2013

WHEREAS, a grant from the State of NJ, Department of Treasury in the amount of TWENTY-EIGHT THOUSAND SEVEN HUNDRED TWO DOLLARS & SEVENTY-FIVE CENTS (\$28,702.45) has become available to the City of Margate City; and

WHEREAS, the Director of the Division of Local Government Services under authority of NJSA 40A: 4-87 may approve the insertion of any special item of revenue in a budget of any county or municipality when such an item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, the Director may also approve the insertion of any item of appropriation for an equal amount.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of the City of Margate City, Atlantic County, New Jersey hereby requests the Director of the Division of Local Government Services approve the insertion of the following item of revenue into the budget of the year 2013 in the sum of \$28,702.75 which is now available; and

BE IT FURTHER RESOLVED that a like sum of TWENTY-EIGHT THOUSAND SEVEN HUNDRED TWO DOLLARS & SEVENTY-FIVE CENTS (\$28,702.45) be and the same is hereby appropriated under the caption "Clean Communities Grant".
