

**RESOLUTION #123-2016**  
**Change Order No. 5 (Decreasing)**  
**2013 Road Program with Asphalt Paving Systems**

**WHEREAS**, on July 3, 2014, Resolution #149-2014, the Board of Commissioners of the City of Margate awarded a contract to Asphalt Paving Systems, Hammonton, New Jersey for the 2013 Road Program in the amount of \$1,573,800.00; and

**WHEREAS**, Resolution No. 39-2015, authorized Change Order No. 1 for additional signage, resulting in an increase of \$16,636.00 changing the contract amount to \$1,590,436.00; and

**WHEREAS**, Resolution No. 78- 2015, authorized Change Order No. 2 for unforeseen change to the Sanitary Sewer Main, Revision for an Loop Detector Replacement, resulting a decrease of \$8,834.63, changing the contract amount to \$1,581,601.37; and

**WHEREAS**, Resolution No. 106-2015, authorized Change Order No. 3 for unforeseen change to the Utility Conflicts and inoperable water valves, decreasing the contract amount by \$655.00, resulting in a new contract total \$1,580,946.37; and

**WHEREAS**, Resolution No. 125-2016, authorized Change Order No. 4 for an unforeseen change in quantity to Douglas Avenue Paving change, and work at 9213 Amherst Avenue decreasing the contract amount to \$1,361,865.42; and

**WHEREAS**, the City Engineer, Edward Walberg submitted a letter dated June 23, 2016 regarding Change Order No. 5, that related to an increase in Casting, Curb Piece Manhole and Gate Valve and a decrease in Fuel and Asphalt Price, Traffic Markings and Curb; decreasing the contract amount by \$397.16, resulting in a new contract total of \$1,361,468.26; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Commissioners of the City of Margate in the County of Atlantic, does hereby authorize the issuance of Change Order No. 5, decreasing the overall contract amount by \$397.16 changing the 2013 Road Program contract with Asphalt Paving Systems to \$1,361,468.26.
