**ORDINANCE NO. 2013-21**

**AN ORDINANCE AMENDING BOND ORDINANCE NO. 2013-14, ADOPTED ON JULY 3, 2013, BY THE CITY OF MARGATE CITY, IN THE COUNTY OF ATLANTIC, NEW JERSEY, WHICH BOND ORDINANCE PROVIDES FOR VARIOUS WATER AND SEWER UTILITY CAPITAL IMPROVEMENTS IN AND BY THE CITY OF MARGATE CITY, TO REPLACE THE DESCRIPTION OF A CAPITAL IMPROVEMENT PROJECT SPECIFIED THEREIN**

**WHEREAS**, the City Commission of the City of Margate City, in the County of Atlantic, New Jersey (the “**City**”), heretofore adopted Bond Ordinance No. 2013-14, entitled:

“BOND ORDINANCE PROVIDING FOR VARIOUS WATER AND SEWER UTILITY CAPITAL IMPROVEMENTS IN AND BY THE CITY OF MARGATE CITY, IN THE COUNTY OF ATLANTIC, NEW JERSEY, APPROPRIATING EIGHT HUNDRED TWELVE THOUSAND DOLLARS (\$812,000) THEREFOR AND AUTHORIZING THE ISSUANCE OF EIGHT HUNDRED TWELVE THOUSAND DOLLARS (\$812,000) BONDS OR NOTES OF THE CITY FOR FINANCING THE COST THEREOF”,

(the “**Original Bond Ordinance**”), pursuant to which the City authorized the issuance of bonds or notes in the aggregate principal amount of \$812,000 for the purpose of financing the costs of various capital improvements to the municipal sanitary sewer, storm sewer and water systems; and

**WHEREAS**, the City desires to amend the description of the type of vehicle and equipment to be purchased by the City pursuant to the Original Bond Ordinance.

NOW THEREFORE, BE IT ORDAINED, by the Mayor and City Commissioners of the City of Margate City, in the County of Atlantic, New Jersey, as follows:

**Section 1.** Section 3 of the Original Bond Ordinance No. 14 be and is hereby amended to read as follows: Under the heading “IMPROVEMENT OR PURPOSE”, the words “one (1) large dump truck” shall be deleted and shall be replaced with “one (1) beach tractor and surf rake”.

**Section 2.** This Amendment does not authorize any additional indebtedness, but merely amends the Original Bond Ordinance to reflect the intended vehicle to be purchased.

**Section 3.** The Original Bond Ordinance is hereby reaffirmed in its entirety and shall remain in full force except as modified herein.

**Section 4.** This Ordinance amending the original Bond Ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law of New Jersey.
