BE IT FURTHER RESOLVED that merchants within the Commercial Retail Districts of the City of Margate may display one six foot table or one six foot clothing rack for every thirty feet of store frontage on the following dates:

July 12, 13, 14, 26, 27, 28
August 3, 4, 5, 9, 10, 11, 23, 24, 25
September 21 and 22
