

2011 Summer Resident Application for Valet Trash and Recycling Collection Service

The ACUA will provide the residence with a 95-gallon lidded, wheeled trash cart and valet service for the 15 weeks of the summer season (May 30 – September 9, 2011). The duration of this service is non-negotiable. The fee for the full summer season is \$235. Applications received through June 30 will be charged \$235. Applications received between July 1 and July 31 will require payment of \$175. Applications received after August 1 will require payment of \$125. All payments include one 95-gallon trash cart which is required for enhanced collection service.

On the scheduled collection day, ACUA's collection staff will retrieve the containers from the residence, empty them and return them to the residence. Participating residents will NOT need to bring containers to the curb.

The ACUA will collect up to two 95-gallon trash carts and two recycling containers at each property on your scheduled collection day. The cart will be the property of the property owner and additional carts may be purchased at a cost of \$53 directly from the ACUA (maximum two trash carts per residence). All trash must be placed in a 95-gallon cart purchased from ACUA. Participating residents are entitled to receive one blue recycling bucket per year as needed. Additional buckets can also be purchased from the ACUA for a fee of \$10.

Enhanced service does not include yard waste collection, construction debris or metals, and does not apply to condominiums, apartments and commercial establishments.

The ACUA will provide the residence with valet service for the 15 weeks of the summer season (May 30 – September 9, 2011). The duration of this service is non-negotiable. The fee for the full summer season is \$182. Applications received through June 30 will be charged \$182. Applications received between July 1 and July 31 will require payment of \$122. Applications received after August 1 will require payment of \$72. Payments do not include the cost of the 95-gallon trash cart (provided with your service previously), which must be used in conjunction with enhanced collection.

On the scheduled collection day, ACUA's collection staff will retrieve the containers from the residence, empty them and return them to the residence. Participating residents will NOT need to bring containers to the curb.

The ACUA will collect up to two 95-gallon trash carts and two recycling containers at each property on your scheduled collection day. The 95-gallon trash cart will be the property of the property owner, and additional carts may be purchased at a cost of \$53 directly from the ACUA (maximum two trash carts per residence). All trash must be placed in a 95 gallon cart purchased from the ACUA. Participating residents are entitled to receive one blue recycling bucket per year as needed. Additional buckets can also be purchased from the ACUA for a fee of \$10.
