AUTHORIZING A CONTRACT WITH NATIONWIDE SCREENING SERVICES "NSS" FOR ADDITIONAL BACKGROUND CHECKS IN COMPLIANCE WITH CITY POLICY NO. 514 PROTECTION AND SAFE TREATMENT OF MINORS.

WHEREAS, the Atlantic County Municipal Joint Insurance Fund ("JIF") and the NJ Municipal Excess Liability Fund ("MEL") require certain additional background checks over and above what the City already performs for Supervisors, Managers and Department Heads of Margate City employees who work with (or may work with) children and minors, and for Non-Supervisors who work with (or may work with) children and minors.

WHEREAS, "MEL" issued a Request for Proposals (RFP's) for vendors that provide these additional background checks, receiving several responses, and selected five (5) vendors that they recommended to the members of the MEL, including the Atlantic JIF, one of which is Nationwide Screen Services "NSS" through Adam Safeguard Agency of Toms River, NJ.

WHEREAS, the prices for these additional background checks are listed in Attachment "A" of this Resolution;

WHEREAS, the listed prices are effective through March 2024;

WHEREAS, "NSS" has provided to the Chief Financial Officer Lisa McLaughlin all of the documentation required in the New Vendor Packet;

WHEREAS, the requests for additional background checks will be administered by the Personnel Officer or his designee, as well as the receipt and filing of all documents in confidential files;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the City of Margate City that a contract will be executed between the City of Margate City and Nationwide Screening Services "NSS," 501 Madison Avenue, New York NY 10022, to be administered through Adam Safeguard Agency, 1187 Washington Street, Suite 2, Toms River, NJ 08753.
