

RESOLUTION #251-2022
AUTHORIZING AWARD OF CONTRACT
TO PROVIDE 2023 CLEANING AND TELEVISIONING OF SEWER SYSTEMS

WHEREAS, on October 20, 2022 the Board of Commissioners of the City of Margate City approved Resolution #201-2022 authorizing the receipt of bids to provide Cleaning and Televisioning of Sewer Systems; and

WHEREAS, the City Clerk did duly advertise for the receipt of said bids to provide Cleaning and Televisioning of Sewer Systems in the Atlantic City Press on November 9, 2022; and

WHEREAS, in connection therewith the following two (2) bid(s) were received by the City Clerk and Qualified Purchasing Agent of the City of Margate City on November 29, 2022:

WHEREAS, the City's Qualified Purchasing Agent, Roger McLarnon, submitted his recommendation letter dated December 6, 2022, that a contract be awarded to Mobile Dredging and Video Pipe, Inc., 1566 Harding Highway, Newfield, New Jersey 08344 as per their proposal to provide January 1, 2023 thru December 31, 2023 Cleaning and Televisioning of Sewer Systems in an amount of \$254,968.00.00; and

WHEREAS, Mobile Dredging and Video Pipe, Inc. is the lowest responsive and responsible bidder for these services; and

WHEREAS, the Chief Financial Officer has certified to the Board of Commissioners that there are sufficient funds in an amount not to exceed \$254,968.00 available under Water Sewer-Video Services 3-05-55-502-414 for the purpose of this award. Amounts for future years is contingent upon sufficient funds being appropriated in the 2023 budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the City of Margate City, County of Atlantic, State of New Jersey that it does hereby award a contract to Mobile Dredging and Video Pipe, Inc., 1566 Harding Highway, Newfield, New Jersey 08344 in an amount not to exceed \$254,968.00 as per their proposal to provide January 1, 2023 thru December 31, 2023 Cleaning and Televisioning of Sewer Systems.

BE IT FURTHER RESOLVED that the award of contract is conditioned upon the delivery and execution thereof within ten (10) days from the date of the within resolution accompanied by such appropriate insurance certificate, affirmative action certificate and performance bond as may be required by the specifications.

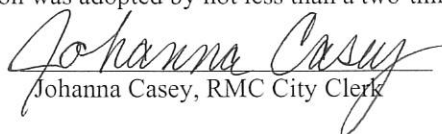
