

**RESOLUTION #120-2020**  
**CONFIRMING ACCEPTANCE OF WORK AS COMPLETE**  
**2019-2020 CURB AND GUTTER PROGRAM PHASE I**  
**HUNTINGTON AVENUE AND FULTON AVENUE**

**WHEREAS**, the Board of Commissioners of the City of Margate City, County of Atlantic, State of New Jersey previously adopted Resolution #80-2020 on April 16, 2020 which authorized the award of a contract to S. Batata Construction, Inc. 238 Ernston Road #1R, Parlin, NJ 08859 in the amount of \$91,700.00 for the 201-2020 Curb and Gutter Program Phase I Huntington Avenue and Fulton Avenue; and

**WHEREAS**, the City Engineer, Ed Dennis has advised in a letter dated June 8, 2020 that the work is complete; and

**WHEREAS**, the Governing Body desires to establish a date of acceptance of work as complete and to authorize the submission of a Maintenance Bond by the aforesaid contractor.

**NOW, THEREFORE BE IT RESOLVED** by the Board of Commissioners of the City of Margate City, in the County of Atlantic, State of New Jersey that it does hereby confirm and otherwise accept as complete the 2019-2020 Curb and Gutter Phase I Huntington Avenue and Fulton Avenue in the final contract amount of \$91,928.00; and

**BE IT FUTHER RESOLVED** that the contractor, S. Batata Construction, Inc. 238 Ernston Road #1R, Parlin, NJ 08859 is now hereby authorized to post a Maintenance Bond in said amount of \$91,928.00 which represents 100% of the total construction costs; said Bond to be in effect for a period of two years from the date of acceptance hereby established as of June 2, 2020; and
