RESOLUTION #74-2020 AUTHORIZING RECEIPT OF RE-BIDS FOR 2020-2021 MARGATE CITY BEACH VENDING

WHEREAS, on February 20, 2020 through Resolution #51-2020, the Mayor and Board of Commissioners authorized the receipt of bids for the 2020-2021 Margate City Beach Vending License; and

WHEREAS, the City Clerk did duly advertise on March 16, 2020 for the 2020-2021 Margate City Beach Vending License; and

WHEREAS, in connection therewith no bids were received by the City Clerk on March 31, 2020; and

WHEREAS, the Board of Commissioners of the City of Margate City authorize the City Clerk to readvertise the 2020-2021 Margate City Beach Vending License to receive bids on April 30, 2020.

WHEREAS, it is in the interest of the City of Margate City to award ONE (1) beach vending license for the 2020-2021 summer season pursuant to the terms and conditions of the Margate City Beach Vending Ordinance and the rules and regulations promulgated thereunder.

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of the City of Margate City, County of Atlantic and State of New Jersey as follows:

WHEREAS, the City of Margate shall conduct a sealed bid on a date to be determined. As the bid opening is commenced in the City Hall Conference Room located at 9001 Winchester Avenue, Margate, New Jersey for the award of ONE EXCLUSIVE LICENSE to sell water, ice cream and ice cream related products on the City of Margate Beaches between Coolidge Avenue and Fredericksburg Avenue for the 2020 summer season commencing on May 22, 2020 and terminating on October 1, 2020. For the summer season of 2021, commencing May 1, 2021 terminating October 1, 2021. This license is not applicable to street vending; and

WHEREAS, the minimum bid is \$50,000.00 per year. The successful bidder is required to make full payment of the difference between the final bid amount and the \$20,000 deposit no later than May 15 for 2020 awarded year. The City of Margate reserves the right to adjourn or cancel the auction without prior notice and to reject any and all bids.

WHEREAS, NOTICE IS HEREBY GIVEN THAT VETERANS ARE PERMITTED, IN ACCORDANCE WITH NEW JERSEY STATE LAW, TO VEND WATER, ICE CREAM AND ICE CREAM RELATED PRODUCTS, IN NON-MOTORIZED VEHICLES, AT THE BEACH BLOCK STREET ENDS OF THE CITY OF MARGATE.

WHEREAS In order to be eligible to bid, each bidder must post a deposit in the form of a certified check in the amount of \$20,000.00 made payable to the City of Margate City. The deposits of the unsuccessful bidders shall be returned within ten days. Under no circumstances shall interest be due or payable to any bidder.


