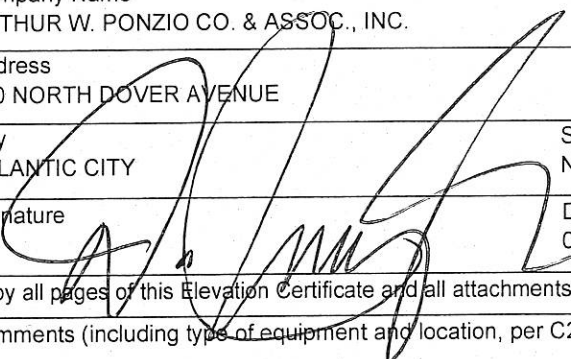

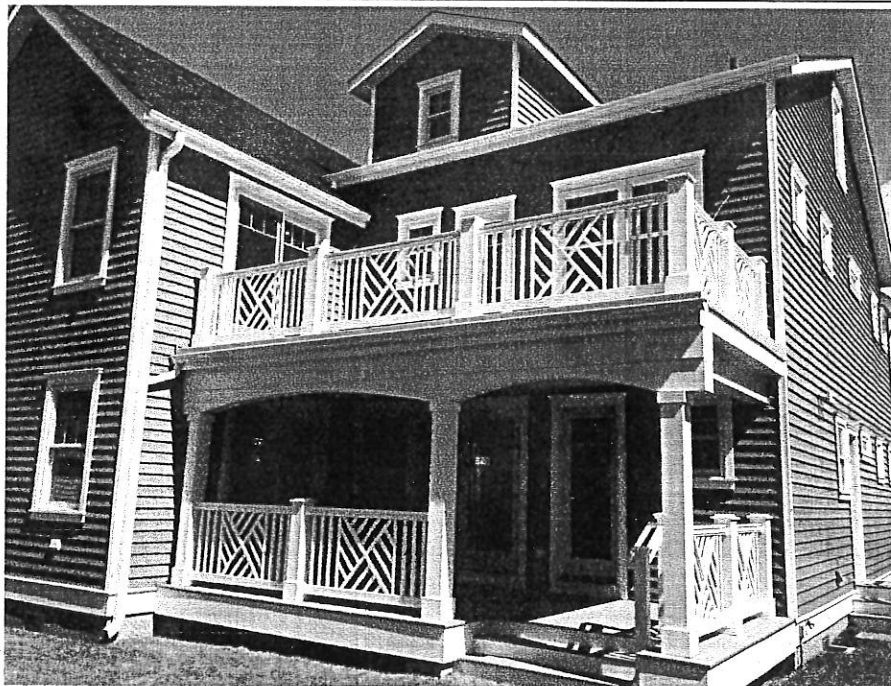

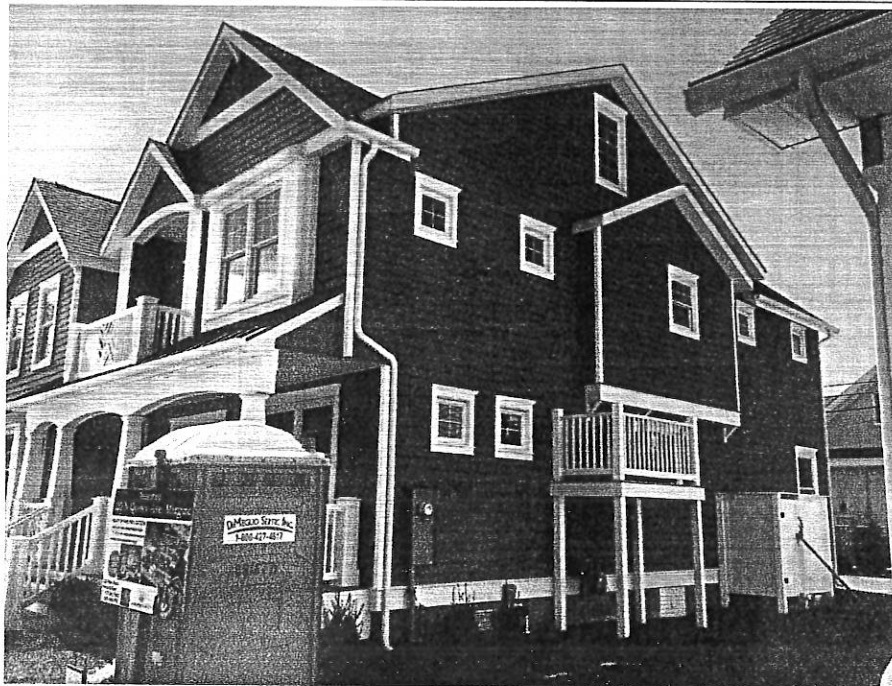

Photo One Caption RIGHT SIDE VIEW

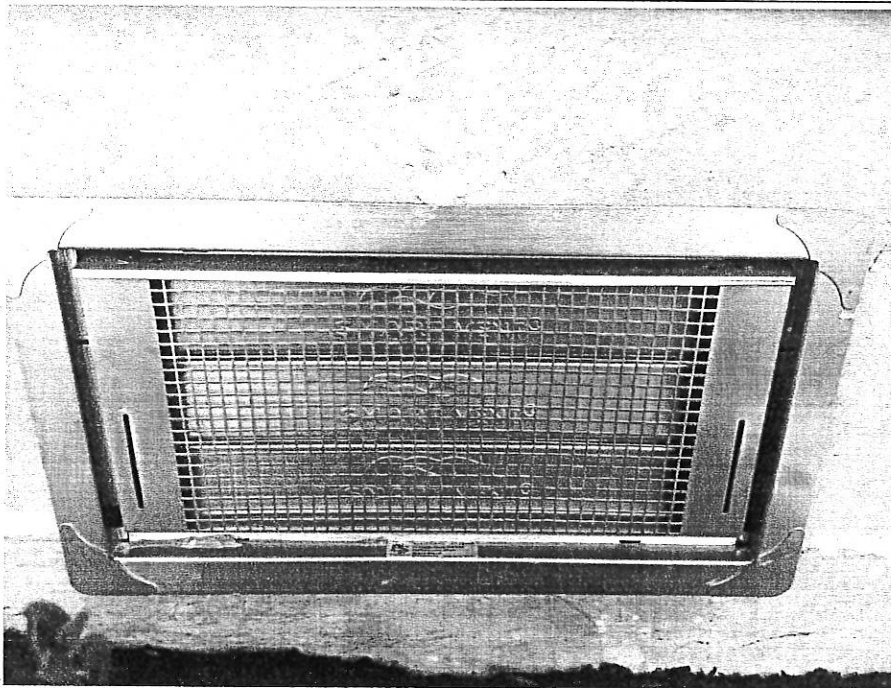
