NOTICE OF FILING OF ELECTRIC RATE INCREASE AND PUBLIC HEARINGS TO CUSTOMERS OF ATLANTIC CITY ELECTRIC COMPANY

IN THE MATTER OF THE PETITION OF ATLANTIC CITY ELECTRIC COMPANY FOR APPROVAL OF A TRUE-UP OF ITS ENERGY EFFICIENCY SURCHARGE, AND TO SET ITS ENERGY EFFICIENCY SURCHARGE FOR PLAN YEAR TWO OF ITS ENERGY EFFICIENCY PROGRAM

PLEASE TAKE NOTICE that, on or about February 28, 2022, Atlantic City Electric Company ("ACE" or "Company"), a New Jersey public utility, filed a petition with the New Jersey Board of Public Utilities ("Board" or "BPU") seeking the Board's approval of proposed changes to electric rates to provide for cost recovery associated with the Company's Energy Efficiency Program ("Petition").

On April 27, 2021, the Board issued an Order approving the Company's Energy Efficiency Program proposed in BPU Docket Nos. QO19010040 and EO20090621. The Order approved an Energy Efficiency Program comprised of approximately \$96.1 million in energy efficiency programs and administration costs to be implemented over a three (3)-year period beginning on July 1, 2021. The Company's Energy Efficiency Program is focused on helping all classes of customers identify and implement measures to reduce their use of energy in keeping with New Jersey's Energy Master Plan. The Order also authorized the Company to recover the costs of the Energy Efficiency Program through inclusion of an Energy Efficiency Surcharge in ACE's Rider Regional Greenhouse Gas Initiative ("Rider RGGI").

If the Board approves this request, the monthly bill for a typical residential customer (using approximately 680 kWh/month) will increase by \$0.29 or approximately 0.20%. The exact amount that your bill will increase depends upon the amount of electricity you use. Two (2) charts are included with this Notice of Filing ("Notice") to help residential customers assess the impact of the proposed new rates on their monthly bills.

The Company filed the following changes to its existing rates with the Board. The following table demonstrates the Company's proposed rates:

The above assumes that customers receive their electric supply from the Company and not from a third-party supplier.

The percentage increase for residential customers noted above is based upon a comparison with current rates as of February 1, 2022. Any final rate adjustments found by the Board to be just and reasonable may be modified and/or allocated by the Board in accordance with the provisions of N.J.S.A. 48:3-4, and for other good and legally sufficient reasons, to any class or classes of customers of the Company. Therefore, the rates set out above may increase or decrease based upon the Board's decision.

A copy of the Notice and public hearings on the Petition is being served upon the clerk, executive or administrator of each municipality and county within the Company's service territory. The Petition and Notice have also been sent to the New Jersey Division of Rate Counsel ("Rate Counsel"), who will represent the interests of all ACE customers in this proceeding.
