### CITY OF MARGATE 2018 EMPLOYMENT AND RETIREMENT AGREEMENT WITH POLICE CAPTAIN KENNETH M. BERGERON

This Employment and Retirement Agreement is made by and between Kenneth M. Bergeron (herein after "Bergeron") and the City of Margate (herein after "City"), a municipal corporation of the State of New Jersey, as set forth the 26<sup>th</sup> day of April 2018.

WHEREAS, Bergeron currently serves as a Captain of Police with the Margate City Police Department; and,

WHEREAS, both the City and Bergeron desire to memorialize in writing an agreement pertaining to Bergeron continuing to serve in his position until his retirement effective June 30<sup>th</sup>, 2018.

NOW, THEREFORE, the parties agree as follows;

- TERM OF AGREEMENT AND COMPENSATION: This agreement shall cover the time period of January 1<sup>st</sup>, 2018 through June 30<sup>th</sup>, 2018. The annual salary increase for this time period shall be 3%.
- HEALTH INSURANCE: Bergeron shall receive the same medical, prescription, dental and vision insurance, if applicable, that other non-union City managerial employees receive.
- VACATION: Bergeron will receive fifteen (15) eight (8) hour days vacation.
- SICK TIME: Bergeron shall be entitled to seven point five (7.5) sick days, in addition to any previously accumulated sick days.
- HOLIDAYS: Bergeron shall be entitled to be off from duty for six (6) recognized holidays.
- OVERTIME: Bergeron shall not be entitled to receive and shall not be eligible to receive overtime pay or any other time off in his capacity as Police Captain.
- 7. RETIREMENT PAYMENTS: It is acknowledged that the official retirement date is June 30<sup>th</sup>, 2018 at which time the Bergeron pension will be based on the compensation figure at the end of his employment. In addition, Bergeron shall be eligible for payment of unused vacation and sick time as follows;
  - a. One Hundred (100) Sick Days at the current daily Police Captain rate of pay, which is \$583.55, for a total of \$58,355.00

- Sixty-six (66) Sick days at the current daily Police Lieutenant rate of pay, which is \$533.38, for a total of \$35,203.08
- Up to, but not to exceed twenty-one (21) vacation/holidays at the current Police Captain daily rate of pay.
- 8. FULLY BARGAINED AGREEMENT: This agreement contains all of the promises and understandings of Bergeron and the City and there are no other agreements or understandings, except as set forth herein. This agreement and the obligations contained herein may be amended only by a subsequent written agreement signed by Bergeron and the City, with the approval of the Commissioner of Public Safety.
- GOVERNING LAW: This agreement shall be covered by and considered and
  enforced in accordance with the laws of the State of New Jersey without regard to any
  principles of choice of law that may otherwise be applicable.
- ACKNOWLEDGEMENT: By signing this agreement, Bergeron states that;
  - a. He has read it;
  - b. He agrees with everything in this agreement;
  - He has been advised to consult with an attorney of his own choosing prior to executing this agreement;
  - d. He has been given what he considers to be a reasonable period of time to review and consider this agreement prior to signing it;
  - He has been advised he may revoke this agreement within seven (7) calandar days of signing it; and,
  - f. He has signed this agreement knowingly and voluntarily and is able to do so of his own free will.
