The Regular Meeting of the Board of Commissioners was held on the above date at 4:40 p.m. at the Margate City Hall, 1 South Washington Avenue, Margate, NJ 08402. The meeting began with a flag salute and roll call: Mayor Becker, Commissioner Amodeo and Commissioner Blumberg were present. Ms. Bascelli, Ms. Casey and Mr. Abbott were also present. The minutes from February 1, 2018 Regular, Workshop and Capital Meetings were approved as read on motion by Commissioner Blumberg, seconded by Commissioner Amodeo with a vote of three ayes.

Public Comment:

Ben Zeltner, Esq: Representing Harbor Bay LLC- Mr. Zeltner inquired as to the possibility of the City conveying 3 ft. X 100 ft. of City owned parking spaces located on Amherst Avenue and to obtain permission from the Governing Body to include the parcel of land when they make their presentation to the Planning Board. After the Governing Body's review of the newly presented proposed plans, Mayor Becker granted the approval in principle for Harbor Bay LLC to make their presentation to the Planning Board.

John Sewell: 22 West Drive: Mr. Sewell expressed his concern regarding our school budget and spending, feels that the City needs to close a school and consider shared services with the City of Ventnor, including a shared Superintendent.

Fred Tursi: 9400 Amherst Avenue: Mr. Tursi spoke against the change in zoning addressed in Ordinance #2-2018, feels that there was a defect in the resident notification process and shared his concern about no longer being able to enjoy the view from his property at Harbor Vista; which was the reason he purchased his property.

Steve Worner: 103 N. Sumner Ave: Requested for the City to take another hard look at our schools and hopes that the next School Board Member to be appointed will look out for the tax payers.

Commissioner Blumberg took a moment to thank the members and representatives of our School Board, not only for their involvement, but for their time and efforts to better our community and our schools.

Commissioner Amodeo and Mayor Becker echoed Commissioner Blumberg's comments and added that it is admirable that our residents donate their time to the various boards to continue to keep our town the great town it is.

Seeing that there were no further comments, a motion to close the Public Comments was put forth by Mayor Becker, seconded by Commissioner Amodeo with a vote of three ayes.
