The Regular Session of the Board of Commissioners was held on the above date and began with a flag salute and roll call by Mr. Hiltner: Mr. Becker and Ms. Taube were present. Mr. Blumberg was absent. Mr. Deaney and Mr. Abbott were also present. The minutes from June 6, 2013 were approved as read on motion by Ms. Taube with a unanimous vote.

Public Comment

Harold Kline, 100 N. Huntington Avenue asked for help with traffic on Winchester Avenue during storms & asked for enforcement of "no trucks allowed" in his area. John Sewell spoke on possible school closing. Mr. Sparta, 120 N. Madison Avenue asked that only 1 crosswalk at each intersection be painted on Atlantic Avenue to help with confusion. Steve Altman asked that public service announcements be made regarding State pedestrian crossing laws. Art Cautilli suggested changing wording on beach block parking signs. Mr. Miskalski commented on white & yellow lines (parking) and asked that the ones around City Hall be re-painted, asked that employees be respectful of neighbors when parking, and applauded upkeep of City Hall public areas. Sharon Simon spoke about "finger pointing" by commissioners and asked again for a resolution to have solicitor review prior to news releases from commissioners regarding legal and employee matters. She also commented that Facebook comments by commissioners are inappropriate (i.e. Little League comments placed by Ms. Taube). On motion by Ms. Taube this portion was closed with a unanimous vote.

John Sewell commented on Ordinance #13 (*opposed*) and Resolution #131. Sharon Simon asked for explanation of Ordinance #15 (*Mr. Deaney*) and Resolution #134 (*Ms. Taube*).
