March 6, 2014 Margate City, New Jersey

The Board of Commissioners held its Regular Meeting on the above date at 5:00 p.m. The meeting began with a flag salute and roll call: Mr. Becker, Mr. Blumberg & Ms. Taube were present. Chief Wolfson (Assistant City Administrator) & Mr. Abbott were both present. Minutes from February 20, 2014 were approved as read on motion by Ms. Taube with a vote of two ayes. (*Mr. Blumberg did not vote since he was absent on 2/6/14*)

**Public Comment:** John Sewell: enact a cloth jaw strap ordinance. Sharon Simon: legal fees too high & thought putting Ms. Taube's letter to Ford Scott re: Tom Hiltner prior to the 2011 Audit was poor decision and may cause more legal problems. Ed Berger: beach advertising good idea for small businesses in Margate & is non-obtrusive and tasteful. (*Mr. Blumberg: advertising approved by 2 previous commissions unanimously, therefore, any changes should be made by full commission vote. Favors continuing the advertising since these businesses help the city in many ways throughout the year. Ms. Taube disagreed with Mr. Blumberg and is opposed to beach advertising & it has no value to the city). Steve Woerner: if advertising is continued the city should raise its rates. This portion was closed on motion with a vote of three ayes.* 

**Public Comment on Agenda Items**: John Sewell: commented on Resolutions #55 (*legal fees already too high*), #60 (*Mr. Hiltner explained*), and #65 (*oversight urged*). Ed Berger described trees available through #65. Sharon Simon: Resolution #62 (*wait on this until policy set especially since Mr. Deaney suggested same*) & Steve Woerner disputed Ms. Simon. Mr. Blumberg read an email from Mr. Deaney explaining his opinion that a policy should be in place before naming public land for someone; city has never allowed this before. This portion was closed on motion by Ms. Taube with a vote of three ayes.

**Agenda Items:** All ordinances will be advertised according to law by the City Clerk's office. The second reading & public hearing for Ordinance #9 is scheduled for April 17th @ 5:00 p.m. All ordinances may be found in full in the City Ordinance Book located in City Hall.
