The Board of Commissioners held its Regular Meeting on the above date at 5:00 p.m. The meeting began with a flag salute and roll call: Mr. Becker, Mr. Blumberg, & Ms. Taube were present; Mr. Abbott & Mr. Deaney were present. The minutes from November 7, 2013 were approved as read on motion by Mr. Blumberg with a vote of three ayes.

**Public Participation:** John Sewell asked the city to be more diligent with dog licensing and urged for more stringent laws for dogs especially pit bulls. Joel Fogel & Art Cautilli commented on the Dunes project and the referendum vote opposing participation in the project. Bill Phillips, 8201 Amherst Avenue asked for more enforcement by police department of speeding and running stop signs within the city especially his street and neighborhood where there is so much abuse. Mr. Blumberg defended the police officers and explained that he (as Commissioner of Public Safety for 4 years) commissioned a traffic study which did not show excessive speeding in the mentioned area and also for a study to place stop signs at Tighe School on Amherst Avenue but that could not be done safely. Mr. Becker asked for more time so that he could speak directly with the Police Chief. Mr. Deaney asked that Mr. Phillips bring him any photos he has taken showing cars running stop signs. On motion this portion was closed with a vote of three ayes.

**Public Participation on Agenda Items**: John Sewell asked for more information on Resolution #230 (Mr. Hiltner provided same)

On motion by Mr. Blumberg this portion was closed with a vote of three ayes.
