AN ORDINANCE AMENDING CHAPTER 257, VEHICLES AND TRAFFIC, OF THE CODE OF THE CITY OF MARGATE CITY, COUNTY OF ATLANTIC AND STATE OF NEW JERSEY

BE IT ORDAINED by the Commissioners of the City of Margate, County of Atlantic and State of New Jersey that;

SECTION 1: 257-35, <u>Loading Zones</u>, shall be amended to ADD the following loading zone:

Adams Avenue West 7:00 am to 5:00 pm From a point starting
23 feet North Ventnor

Avenue and Adams Avenue from the Northwest corner to a point 37 feet North thereof

SECTION 2: All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

SECTION 3: This ordinance shall take effect upon final adoption and publication and in the manner provided by law.
