The Margate City Board of Commissioners held a work meeting on the above date at 4:00 p.m. The meeting began with a flag salute & roll call: Mr. Becker, Mr. Amodeo and Mr. Blumberg were present. The following department heads were present: Mr. Verna, Mr. Ricciotti, Mr. Rubin, Ms. McLaughlin, Mr. McLarnon, Chief Tabasso, Ms. Casey, Ms. Larkin, Mr. Galantino, Mr. Walberg and Chief Wolfson. Mr. Abbott was also present.

**Items for Discussion:**

Mr. Abbott: Vacation of Clarendon Ave. Subdivision and Sale of Quincy Ave. Modify Water and Sewer Delinquent Fees Ordinance. Possible purchase of Block 602.04 Lot 19.

**Department Reports:**

Mr. Abbott: February 4, 2016 trial went well, attorneys did a fantastic job.

Mayor Becker: I agree, we had a very good day in court. We will be back to hear the state present their case tomorrow.

Mr. Walberg: Road program, Harding Ave from Monmouth to Winchester complete. Monroe Ave from Monmouth to Winchester complete. 2013 Beach bulkhead access will start any day. City Hall 75% complete outside. Next meeting on next Thursday. Generators ran well for the storm on Saturday. Gas Company is keeping us up to date.

Mayor Becker: Public work did a great job with the storm, thank you.

Mr. Ricciotti: We put in 34 hours straight during that storm. Had to do a lot of cleaning. Video pipe is getting a good look at the drainage and we should have the report soon. Bulkhead gave out on Jefferson Ave.

Mr. Amodeo: Getting a lot of flooding on Amherst and Huntington Ave, it is too much for the pipe to handle

Mr. Ricciotti: It is too much for the pipe to handle, we will look into how to fix it.

Chief Tabasso: Regarding Storm Jonas, everything went well with Fire Department.

Ms. McLaughlin: Capital Ordinance #03-2016 to fund completion of City Hall and will be reimbursed 90%. Annual Debt statement has been submitted and posted to the city website. Annual finance statement will be filed by the 10<sup>th</sup> of this month.

Chief Wolfson: Police department did a great job with the storm. Everything is good at the Business Department.

Ms. Casey: Nothing to report.

Mr. Abbott: Nothing at this time.

Mr. Rubin: Post Sandy Grant, Phase 1 study is in final version. Requesting Nov 25<sup>th</sup> zoning recommendation be summarized on Feb. 18<sup>th</sup> meeting, 15-20 min presentation on the study.

Outstanding Escrow for 47 properties, we have only had 8 responses and would like to only peruse the ones which are built low.

Mr. McLarnon: Solar panels are under control and are generating income. We will receive a check this upcoming week for \$60,000 for the last 3 years.

Ms. Larkin: Moving into 1 South: 4-6 weeks needed for the court.
