## Items to Discussion:

D2. Proposed Zoning Change- Overlay District/ Flood (Amherst Avenue) (*McLarnon/Galantino*)

Mr. McLarnon informs Commission on proposed Zoning changes that the Planning Board is in favor of. Mr. McLarnon speaks on Flood Damage Prevention Ordinance has to be rewritten due to mandatory language that the DEP requires has to be in the Ordinance.
