## AN ORDINANCE AMENDING ORDINANCE #21-2016 FIXING THE SALARIES & WAGES AND

## COMPENSATION OF CERTAIN OFFICERS & EMPLOYEES OF THE CITY OF MARGATE CITY, ATLANTIC COUNTY, NEW JERSEY

THE BOARD OF COMMISSIONERS of the City of Margate City, Atlantic County, New Jersey does ordain

**SECTION 1: THAT** effective January 1, 2017 the base salaries, wages, and compensation to be paid to the following officers and employees of the City of Margate City, New Jersey shall be paid biweekly and as follows:

**SECTION 2**; THAT in lieu of pay adjustment in consideration of Reduction of Benefits, the Construction Official, Police Chief, Police Captains, Public Works Director and System Analyst may for 2017 only exchange up to five (5) sick days for compensation at their daily rate of pay.

**SECTION 3**; THAT in addition to base pay employees shall receive such compensation, longevity and other contracted benefits as provided in labor contracts or written conditions of employment approved by the governing body or as otherwise provided by law.

**SECTION 4**; THAT the Business Administrator shall cause to be formulated a list of employees eligible for overtime to be filed annually with the City Clerk and CFO.

**SECTION 5**; THAT once established for the calendar year base pay may not be supplemented through merit t raises during the calendar year without approval of the majority of the Governing Body.

**SECTION 6;** THAT all ordinances and parts of ordinances inconsistent herewith are hereby repealed but only to the extent of such inconsistency.

**SECTION 7;** THIS ordinance shall take effect upon final passage and publication as provided by law.
