**AUTHORIZING APPLICATION AND EXECUTION OF
AMERICAN RESCUE PLAN FIREFIGHTERS GRANT**

WHEREAS, the Board of Commissioners of the City of Margate are desirous to apply for and obtain a grant from the New Jersey Department of Community Affairs for approximately \$115,000.00 to carry out a project to fully equip all personnel with a set 2nd set of turnout gear per NFPA compliance; and


WHEREAS, the purpose of this application is to fully equip the Margate City Fire Department with new Personal Protective Equipment, specifically Turnout Coats and Turnout Pants. With the COVID-19 Pandemic, we have responded to a number of high frequency calls involving incidents related to COVID-19 patients and contamination; and


WHEREAS, City of Margate agree to pay their required share of the cost of this grant; and

WHEREAS, an agreement has been presented and reviewed and is found to be acceptable; and

WHEREAS, Board of Commissioners of Margate City, State of New Jersey, that the City of Margate City Fire Department does hereby authorize the application for such a grant; and, recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the execution of any such grant agreement; and also, upon receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between the City of Margate City Fire Department and the New Jersey Department of Community Affairs.


