WHEREAS, Edward Dennis, City Engineer, submitted a letter dated October 27, 2021 regarding a reduction in Change Order #3 that relates to as-built quantities in the amount of (\$691.86), resulting in a new contract total of \$236,380.36.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the City of Margate City, County of Atlantic, State of New Jersey does hereby approve Change Order #3 (Reduction) to the contract with Zone Striping, Inc., 718 Jacob Harris Lane, PO Box 568, Glassboro, NJ 08028 to the new contract amount \$236,380.36 for FY2020 State Aid Atlantic Avenue Road Diet.
