

RESOLUTION #237-2021

**AUTHORIZING AWARD OF CONTRACT TO TRIDENT MARINE PILING
COMPANY FOR MARINA ACCESS FLOOD GATES**

WHEREAS, the Board of Commissioners of the City of Margate City, County of Atlantic, State of New Jersey has a need for Marina Access Flood Gates; and

WHEREAS, this proposal is being considered without competitive bidding because it is a below the bid threshold and is an exception to the Local Public Contracts Law, *N.J.S.A. 40:A11-3*, et.. seq., (1)(a)(i).; and

WHEREAS, Edward Dennis, City Engineer, received two proposals dated April 23, 2020 for Marina Access Flood Gates from;

WHEREAS, Edward Dennis, City Engineer, submitted a letter of recommendation dated October 22, 2021 that the contract be awarded to the lowest responsible bidder Trident Piling Co, LLC, 107 Hospitality Drive, Longport, NJ 08403 as per their bid proposal in an amount of \$12,500.00; and

WHEREAS, the Chief Financial Officer has certified to the City Commissioners that there are adequate funds available in Buildings & Grounds-Landscaping & Parks, account 1-01-26310-281 for the purpose of awarding of this contract for \$12,500.00.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the City of Margate City, County of Atlantic, State of New Jersey that it does hereby award a contract to Trident Piling Co, LLC, 107 Hospitality Drive, Longport, NJ 08403, as per their bid proposal for Marina Access Flood Gates in an amount not to exceed \$12,500.00.
