WHEREAS, N.J. P.L. 2011, Chapter 130 authorizes local government to purchase goods and services from nationally recognized purchasing cooperatives that have competitively bid their contracts and are developed by contracting units from New Jersey or other states; and

WHEREAS, The Interlocal Purchasing System (TIPS), Region 8 Education Service Center, 4845 US Highway 271 North, Pittsburg, Texas 75686, hereinafter referred to as the "Lead Agency" has offered voluntary participation in a Cooperative Pricing Program for the purchase of goods and services; and

WHEREAS, on December 3, 2020 the governing body of the City of Margate City, County of Atlantic, State of New Jersey desires to participate in The Interlocal Purchasing System (TIPS). TIPS is a National Cooperative Purchasing Program offered by Region VIII Education Service Center, located in Pittsburg, Texas, (Camp County) for the provision and performance of goods and services;

NOW, THEREFORE BE IT RESOLVED as follows:

TITLE

This RESOLUTION shall be known and may be cited as The Interlocal Purchasing System (TIPS) Resolution of the City of Margate City

AUTHORITY

Participation, through membership and utilization of competitively bid and awarded vendor contracts in a cooperative purchasing program specializing in the management of high quality cooperative procurement solutions will be beneficial to the taxpayers through the anticipated savings to be realized by such entity listed above.

THEREFORE, BE IT RESOLVED that the City of Margate City has identified a need for participation in The Interlocal Purchasing System (TIPS) whereby Roger McLarnon, Qualified Purchasing Agent, is authorized and directed to sign and deliver any and all necessary documents herewith for and on behalf of the City of Margate City requesting membership in TIPS.
