SUBJECT: Construction Work on Existing Buildings in Flood Zones/

Substantial Improvement

The City of Margate's floodplain management regulations and codes specify that all new buildings to be constructed in Flood Zone areas are required to have their lowest floors elevated to or above the base flood elevation (BFE). The regulations also specify that **substantial improvement** of an existing single family residence (remodeling, rehabilitation, improvement, or addition) must be brought into compliance with the requirements for new construction.

Substantial improvement means any reconstruction, rehabilitation, addition, or other improvement of a structure, the cost of which equals or exceeds 50 percent of the market value of the structure before the "start of construction" of the improvement. This term includes structures that have incurred "substantial damage," regardless of the actual repair work performed.

To make the **substantial improvement** determination, we compare the cost of the proposed improvement or repairs to the market value of the building (excluding land, accessory structures, and landscaping). If the resulting ratio equals or exceeds 50 percent, the existing building must be brought into compliance with the floodplain management requirements for new buildings.

The City of Margate requires all Property Owners and Home Improvement Contractors to acknowledge that they have received this notification relative to Substantial Improvement.

Should an inspection on a Substantial Improvement property be performed and a Substantial Improvement determination is made, a notice of violation will be issued and the Property Owner/Contractor must stop all construction and apply for a house elevation permit.

Please note that **ALL** applications for permits to work on existing buildings that are located in Flood Zone areas must include the attached **Owner's affidavit (signed and dated) and/or Contractor's affidavit (signed and dated).**
